Directions: Shake well before each use. This product is miscible with the most commonly used plant protection active ingredients and fertilizers. Before using, it is recommended to make preliminary tests of compatibility and incorporate it last, while maintaining agitation in the mixture. Apply using a spray method in an adequate amount of water that will provide complete coverage of the plants. Use of a non-ionic wetting agent may improve spray coverage of certain hard to wet plants. Carry out the treatments in the cooler hours of the day (morning or evening) to exploit the moments of maximum absorption of the plant. Do not apply undiluted.

Storage and Disposal: Store in a dry place at temperatures between 39 °F and 110 °F. Store in a safe manner. Store in original container only and keep tightly sealed when not in use. Do not contaminate water, food or feed by storage, disposal or cleaning of equipment. Dispose of unused product and empty containers in accordance with federal, state and local regulations. Due to the plant-based material separation and color variations are normal.
